This Hunting Test is held under the rules and regulations of the AMERICAN KENNEL CLUB.

In accordance with AKS Regulations for Hunting tests for Pointing Breeds, amended Nov. 2011, section 15: "Order of running shall be decided by lot at the draw. Dogs worked by the same person or belonging to the same owner will be separated. The Draw is determined by random chance insofar as possible." Please note, this is a random drawing, dogs and bitches will be chosen at random. Special requests for bracing changes will not be accommodated. Conflicts for handlers handling multiple dogs will be determined by the Line Marshal on the day of the event. Dogs must be at the start point for their brace 5 minutes prior to starting.

## Rules of Quail Point Hunt Preserve

**NO SMOKING on property except for INSIDE your enclosed vehicle.**

2. a. Hunters must park in designated parking areas and are **NOT permitted to drive in the fields.**
- b. Overnight camping allowed only in trailers, motor homes, or campers and at the clubhouse only. No hookups available.
3. NO HUNTING allowed on the property unless an authorized agent of Quail Point Hunting Preserve is on the property.
4. Show common courtesy among others. Do not cut in front of others. Do not shoot across roads or hills where the view is not clear. No hunting when the fog is dense enough to be unsafe. Guns should be on "safety" while hunting in the field or walking on the Sporting Clays Course. No loaded guns in vehicles or the Clubhouse area. Please strictly adhere to all hunter safety guidelines.
5. Members/hunters are expected to stay on club property, which is clearly marked. **DO NOT CROSS ANY FENCE LINES!**  
To do so you are trespassing onto neighbor's property.
6. Safety areas are well marked. No **shooting into a safety area!**
7. No shot size larger than 6 allowed. No high base shells.
8. Everyone **MUST SIGN IN and OUT EACH DAY AT THE CLUBHOUSE DESK.**
9. **Hunter orange MUST be worn at all times while hunting. A hat and/or vest are required.** Safety glasses are recommended.  
Hats, vest and glasses are available at the clubhouse desk.
10. No alcoholic beverages are permitted while hunting or on the course.  
Anyone drinking alcohol or causing disturbances will be discharged from the Club.
11. All members/hunters shall make every effort to find dead or wounded birds.
12. Do not pluck or draw birds in the field. Do not litter the fields with cans, bottles, shell casings etc. Please help keep the premises clean! Please pick up spent shell casings.
13. All dog feces and waste must be removed from the parking area.

AGREEMENT FOR ASSUMPTION OF RISK, INDEMNITY, AND RELEASE FROM LIABILITY;

1. I, \_\_\_\_\_, acknowledge that I have voluntarily applied to IRISH SETTER CLUB OF THE PACIFIC, INC. (ISCP) to participate in hunting test activities ("field events") sponsored by ISCP, its officers and members, to be held Quail Point Hunt Club, Zamora, CA
2. **ASSUMPTION OF RISK:** I am aware that field events are a hazardous activity and involve inherent risks and dangers, which could cause serious injury or death, including the following risks: the discharge by gunners and others of firearms with live ammunition; the presence of wild game either as the object of the trial or indigenous to the trial grounds; the use and presence of horses and dogs of unknown temperaments, degrees of training and control by their respective owners and handlers; and the use of motor vehicles on and off the field event grounds by various persons (and who may or may not have liability insurance). I understand that these risks and others not specifically enumerated herein exist both during the actual field event and at other times before and after the event while the grounds are occupied by ISCP for purposes of conducting the field event over a period of one or more days to its conclusion.
